Remarks at Holy Cross Hospital's 50th Anniversary Reception January 9, 2013

The Honorable Isiah Leggett Montgomery County Executive

WHEREAS, the Board of Trustees, staff and volunteers at Holy Cross Hospital, have consistently built upon the legacy of the Sisters of the Holy Cross, ensuring outstanding and compassionate healthcare for over 50 years.

WHEREAS, Holy Cross Hospital is the leader in innovation and healthcare in the Washington, DC region pioneering in many medical specialists.

WHEREAS, to ensure continued innovation, Holy Cross Hospital establishes and maintains a teaching affiliation to George Washington University Medical School.

WHEREAS, Holy Cross Hospital has effectively responded to the Sisters of the Holy Cross' commitment to Healthcare for the poor, but provided millions of dollars in uncompensated healthcare to the poor and uninsured in the hospital and through community innovation health centers in Silver Spring, Gaithersburg and Aspen Hill.

And WHEREAS, under the leadership of Kevin Sexton, President and CEO, Holy Cross Hospital has been designated a top performing hospital by the Joint Commission on Healthcare Accreditation for two years in a row; the only Maryland hospital to see that honor.
